 - a. LGA funds being reduced
 - b. State cutting back on Health and Human Services due to cuts in Federal Medicaid funding

1. Administrative Department

- a. Regular daily, weekly, monthly
- b. FY26 grant funding info has been sent to senators
- c. Kettle River Snowmobile Club
 - Requested permission to run pull tabs at the Kettle River Bar and Grill
 - ii. City has received their paperwork
 - iii. City has informed the Snowmobile Club that 10% of proceeds go to the City of Kettle River
- d. Resident turned water on to fill swimming pool
 - i. Carlton County deputy called in
 - ii. Tool that was used to turn on water was confiscated per direction of deputy
 - iii. 5000 gallons of water was used and will be billed to resident
- e. Reviewing current city policies and revising based on the League of Minnesota Cities recommendations.
- f. Complaint from resident regarding neighbor's loose dog and toys left in alley
- g. Two disconnect notices going out
- h. AUS (Eric Appelwick) mowed inside ponds, will drop rates if he contracts to do it all summer
- i. Waiting on gravel quotes
 - i. Need to figure out how city streets can be fixed
 - ii. City can't afford to repave streets
 - iii. Options include class 5 gravel, crushed concrete, crush current asphalt and re-lay it (Twin Lakes Township did this)
- j. City Hall parking lot
 - i. Rent mini excavator machine from Imperial Communications to remove first layer blacktop for \$150
 - ii. A&B rents mini excavator for between \$300 and \$400
 - iii. Lay class 5 gravel on top of bottom layer of blacktop
 - iv. Motion to rent equipment from Imperial Communications to remove first layer blacktop for \$150 was made by Councilor Sarvela and seconded by Councilor Kohmetscher. Ayes: Councilor Kohmetscher, Councilor Sarvela, Councilor Mascarenas, Councilor Lund, Mayor Lucas. Nays: none. Motion carries.
- k. Lake Country Power does not drive on grass or soft spots. They did not leave the ruts
- We have \$61.20 left in the cashflow in streetlighting. This is insurance and auditors will adjust as needed. We will know more when we received the completed audit.

2. Utilities Department

- a. Reading meters
- b. Six or seven locates for SCI
- c. Curb stops have gotten buried over time; the city should consider getting risers to fix curb stops as we find them

- d. Talked to AUS (Eric Appelwick) about tamperproof curb stops. Eric's only recommendation was a padlock type device
- e. Internet at plant has been down a lot, waiting for SCI
- f. Reading meters in the morning
- g. New Fleetzoom from AUS is working well according to Eric Appelwick
- h. No restroom vandalism
- i. Lots of geese and goslings, AUS is not overly concerned
- 3. Fire and First Responder Department
 - a. Nine fire calls (seven grass fires, some mutual aid calls), two medical calls
 - b. Surrounding communities (not Moose Lake) are sending equipment to assist with wildfires in northeast Minnesota, Kettle River is not sending equipment to ensure we have necessary equipment to safeguard local area
 - c. Barnum idea of combining fire department was a miscommunication
 - d. Pool filling need to let AUS know, fire department should use different hydrants for each pool fill
 - e. City Hall should be informed if excessive water will be used for any reason
- 4. Personnel Committee
 - a. Jon Lingle performance review was completed
 - b. The Personnel Committee recommends increasing Jon Lingle's wage to \$14.90 with back pay to April 8th because the committee was late with his review
 - c. Motion to increase Jon Lingle's wage to \$14.90 with back pay to April 8th made by Councilor Kohmetscher and seconded by Councilor Lund. Ayes: Councilor Kohmetscher, Councilor Sarvela, Councilor Mascarenas, Councilor Lund, Mayor Lucas. Nays: none. Motion carries.

 - a. The city has received a request for a crosswalk from rest area to the Legion Building because children are crossing the highway to catch the school bus. City Hall is working with the Barnum School District to see if the bus stop can be moved

 - b. Funding for advanced equipment CAD dispatch system (being used by Cloquet, Esko, maybe Barnum) PROs: more accurate, coordinates better with other software.
 - i. Need to see clear benefits to justify the costs (4 units: \$4800 initial + \$500 per year + \$2160 (\$45*4 units*12 months))
 - ii. Call for motion to acquire CAD system for EMS personnel, no motion made, motion fails
 - c. Increase personnel and training, enhanced EMS training
 - i. Currently EMS personnel are given training to meet requirements
 - ii. Jordan Azzam doesn't believe training to a higher level is needed
 - iii. Should have EMS personnel attend the Under One Roof conference (May 20 21), \$150 per person
 - iv. This needs to be discussed as part of the February Fire Commission meeting and then approved by the Kettle River City Council

- d. Infrastructure improvements
 - i. Image Trend Elite if free and Chief Gran approves, this can be implemented
 - ii. Improving Communications Systems: may be required in the future due to current system being outdated and not supported. No indication that we could get a grant for this
 - iii. Modernizing facilities: no funding available for this
- e. Community Services, Outreach and Education
 - i. City would have to adopt a higher level of service to register
 - ii. Future captain will research and propose direction
